Application 7C1412 from Ryegate Associates (Attn: Fahim Samaha 247 Weesner Drive , East Ryegate, VT 05042), Capergy US LLC (254 Commercial Street , Portland, ME 04101), Stored Solar Holdings, LLC (247 Weesner Drive , East Ryegate, VT 05042) and Ryegate Associates (247 Weesner Drive , Ryegate, VT 05042) was received on December 28, 2023 and deemed complete on January 10, 2024. The project is generally described as recovery of heat from the Ryegate Biomass Power Station for wood chip drying, and wood pellet manufacture, on \pm 7 acres of land adjacent to the Power Station. The project includes construction of roads; a scale; truck dumper; moving floor sorters; wet milling line; drying island; storage; truck loading; two pellet boxes; a bagging line; and a stormwater treatment system. The project will support production of \pm 90,000 tons of wood pellets annually, and may include sale of dry wood chips. The project is located at 247 Weesner Drive in Ryegate, Vermont


